

## Haringey Multi-agency Solutions Panel (MASP) FAQs

### What is the MASP?

The Multi-Agency Solutions Panel (MASP) is here to provide creative, problem-solving support and advice to staff across Haringey who are working with residents displaying higher levels of complexity.

### How is MASP different from other Multi-Agency Panels

It can be confusing to know what panels do what in Haringey. Below is a brief outline of current panels and who they support (also see appendix 1).

**MASP:** The aim of the Panel is to ensure that professionals working with people experiencing complex needs/high levels of risk are able to access multi-agency creative, problem-solving support and advice.

**MAPPA:** A set of statutory arrangements as per the 2003 Criminal Justice and Courts Service Act to protect the public, including previous victims of crime, from serious harm by sexual and violent offenders.

**MARAC:** MARAC is a multi-agency meeting which domestic abuse victims/survivors who have been identified as at high risk of serious harm or homicide are referred to.

**CMARAC:** The Haringey Community MARAC is a meeting where information is shared on the highest risk/complex cases in relation to ASB/Crime.

### Who sits on the Panel?

There is a range of identified organisations who will be represented at the panel although it is likely that members will only be asked to attend if a case pertains to their area of work. The membership list is below.

**When does the panel meet?**

The panel will meet the first Tuesday of every month 10am-12pm.

**Can anyone refer into the MASP?**

Yes. We want to ensure all workers across Haringey can access the panel when needed.

**When would I refer to the panel?**

We have developed a risk assessment tool that will support workers across Haringey identify risks and complexity with those that they are supporting. We want to encourage and support agencies working together to manage risks and complexity collectively and to support better connection between us. The tool directs workers to undertaking multi-agency case discussions which can be instigated by any agency and any worker. However, we recognise that there may be barriers to this and if workers have tried to arrange such meetings and these have been unsuccessful then a referral to the MASP can then be made.

**How do I refer to the panel?**

We have one page referral form that needs to be submitted 6 workings days before the panel meets.
