The Haringey (Play Streets) (No. 1) Order 2022

Made: 30th August 2022


Coming into force: 1st September 2022

The Council of the London Borough of Haringey after consulting the Commissioner of Police of the Metropolis, in exercise of powers conferred by section 29 of the Road Traffic Regulation Act 1984(a), and of all other enabling powers, hereby make the following Order: -

1. This Order shall come into force on 1st September 2022 and may be cited as the Haringey (Play Streets) (No. 1) Order 2022.
2. In this Order the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
1. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order and subject to the provisions of paragraph 4 below no person shall cause or permit any vehicle to enter or proceed in Vale Road N4, between its junction with Hermitage Road and its junction with Vale Grove between the hours of 2 pm. and 5 p.m. on the first Sunday in every month, throughout the year.
2. Nothing in this Order shall apply to: -
 - (a) any vehicle connected with the staging of the event;
 - (b) any vehicle that requires essential access to any property in a length of road specified in Article 3 above and is proceeding at a speed of no more than 5 miles per hour and accompanied by an adult in high visibility clothing;
 - (c) any vehicle being used for fire brigade, police or ambulance purposes in an emergency; and
 - (d) anything done with the permission or at the direction of a police constable in uniform or a civil enforcement officer.
3. Schedule 5 of The Haringey (Moving Traffic Restrictions) Order 2021 is hereby amended to include the following:

<i>Roads</i>	<i>Operational times</i>
Vale Road N4	between its junction with Hermitage Road and its junction with Vale Grove between the hours of 2 pm. and 5 p.m. on the first Sunday in every month, throughout the year, providing those times are within daylight hours.

THE HARINGEY (PLAY STREETS) (NO. 1) ORDER 2022

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey on 30th August 2022 made to make the above mentioned Order under Section 29 of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order will be to introduce a play street for the purpose of enabling the road to be used as a playground for children and to prohibit any vehicle from entering or proceeding in Vale Road N4, between its junctions with Hermitage Road and Vale Grove operating between the hours of 2 pm. and 5 p.m. on the first Sunday in every month, throughout the year.

The Order will not apply to any vehicle requiring access to a property within the closed section of road providing that vehicle is travelling at a speed of no more than 5 m.p.h. and is supervised by an adult in high visibility clothing.
3. A copy of the Order referred to above, which will come into force on 1st September 2022, of plans which indicate the locations and effects of the Order, and of a Statement of Reasons for making the Order, may be inspected at the reception desk, Alexandra House, 10 Station Road, Wood Green, N22 7TR or can be viewed online, within six weeks of the date on which the Order was made, at www.haringey.gov.uk/traffic_orders.
4. Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it does not comply with the relevant powers of the Road Traffic Regulation Act 1984, as amended or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.
