Introduction

The Haringey Design Awards are a key part of our commitment to promote, encourage and foster thoughtful and exciting design within Haringey. They provide an excellent opportunity to recognise and raise awareness of high quality buildings and places that make a positive contribution to Haringey's built environment. As well as celebrating great buildings and places, the awards help develop links with stakeholders, and bring together local people, members, architects, developers

and planners to participate in wider discussions and debate around design.

We will continue to promote thoughtful and exciting design in Haringey through policy such as the Haringey Development Charter, the 1st policy in our Development Management Policies, as well as initiatives such as the Design Awards and the Quality Review Panel (QRP), and by demanding high design standards throughout the borough.

2021 will be the sixth year in which the Haringey Design Awards have been held, with previous awards in 2018, 2016, 2012, 2009 and 2006.

Past overall winners include the Alexandra Palace Theatre in 2018, the Broadwaters Inclusive Learning Campus in 2016 and Heartlands High School in 2012.

Judging Panel

Peter Studdert

Chair of judges

Peter is an independent adviser on planning and design based in Cambridge. He has chaired Haringey's Quality Review Panel since 2015 and also chairs the London Legacy Development Corporation's Quality Review Panel. He is Chair of Historic England's Historic Places Panel and a Co-Chair of a number of other Design Review Panels in London and the wider South East. He was previously Director of Planning at Cambridge City Council where he played a leading role in developing the current growth strategy for the Cambridge Sub-region.

Edmund Bird

Edmund Bird has been heritage advisor to Transport for London since 2006, also advising the Greater London Authority and the London Development Agency during this time. He is responsible for managing the heritage consents needed for TfL's 150 or so listed stations on its Underground, Overground and Elizabeth line networks as well as highway schemes in conservation areas and those affecting heritage assets such as listed Thames bridges. Before he joined TfL he was Head of Conservation & Urban Design at the London boroughs of Camden and Lambeth following five years as a planner and conservation officer at the City of Bristol.

Matthew Bradby

Matthew Bradby has been Chair of Tottenham Civic Society since it was established in 2006. He is also Chair of Tottenham Conservation Area Advisory Committee. A long-time resident of Tower Gardens Conservation Area in Tottenham, he has been involved with many social and environmental initiatives in Haringey and beyond. He is passionate about sustainable development, open spaces, and social and built heritage. Matthew works in the charitable sector, in communications.

Louise Forsyth

Louise Forsyth is an Architectural Historian who works as an Inspector of Historic Buildings and Areas for Historic England. She has previously worked in the Designations, Grants and Development Advice teams at Historic Environment Scotland.

Jen Gutteridge

Jen Gutteridge is a regeneration expert specialising in masterplan strategy and works for the London Borough of Enfield as Strategy Manager for the Meridian Water masterplan. Previously she worked in the Royal Docks Team which is a joint initiative between the Mayor of Newham and Mayor of London, where she oversaw strategic development and regeneration projects. Jen sits on the London Borough of Lambeth Design Review Panel and RIBA Planning Advisory Group and has held Associate Lecturer positions at London Metropolitan University and Cardiff University.

Gina Moffat

Gina Moffat is an award-winning young entrepreneur who was helped by The Prince's Trust after she left Holloway prison. She runs the café at Tottenham's 639 Centre, the second she has opened in the area following support from The Prince's Trust Enterprise programme.

Since establishing David Ubaka Placemakers, he has been helping private, public and third sector clients to design, manage and deliver projects.
