1. Introduction

This report sets out the annual parking and traffic enforcement performance statistics and financial information in accordance with Part 6 of the Traffic Management Act 2004.

2. Number of controlled parking spaces

Haringey Council is responsible for 355km of streets and has over 55,000 managed on-street parking and loading spaces that operate within 42 controlled parking zones (CPZs) that cover approximately 75% of the borough.

3. Moving Traffic Enforcement

Haringey Council also enforces moving traffic contraventions, for example disregarding one-way systems, weight limits, as well as other traffic restrictions as is allowed under the London Local Authorities & Transport for London Act 2003 (LLA & TfL Act 2003).

4. Levels of Parking and Traffic Enforcement

The table below provides the number of penalty charge notices (PCNs) issued, broken down by the following enforcement activity categories:

- Parking PCNs
- Bus lane PCNs
- Moving traffic PCNs
- Vehicles removed to the car pound

This information is further broken down by those issued at the higher rate (more serious contraventions), which apply to prohibited parking and those issued at the lower rate (less serious contraventions), which apply to permitted parking for example, parking without permission in parking bays.

9. Financial Information

10. Application of Parking Surplus

The parking account is ringfenced and section 55 of the Road Traffic Regulation Act 1984 sets out how any parking surplus may be spent. In summary, the parking surplus can be spent on:

- Provision of off-street parking
- Meeting the costs of public transport services (concessionary travel)
- Meeting costs incurred by the authority in respect of the maintenance of roads maintained at the public expense by them
- For the purposes of environmental improvement in the local authority's area

Annual Parking Report 2021 - 2022

The Council invested a total of £28,992,836 in concessionary transport and highways maintenance and improvements in 2021/22. This investment is broken down by category below:
