# THE HARINGEY (PARK LANE N17) (TEMPORARY RESTRICTION OF TRAFFIC) ORDER 2024

The Council of the London Borough of Haringey has made under s14(1) Road Traffic Regulation Act 1984 the above Temporary Traffic Order as described below:-

Park Lane N17, Worcester Avenue N17, Bromley Road N17, Vicarage Road N17,
Sutherland Road N17, Park Lane Close N17

**Reason for 14(1) Order** – To ensure safety of pedestrians and accessibility of emergency services during Tottenham Hotspur events

The provisions of the Orders shall apply only at such times and as directed by traffic signs. For road closures, alternative routes will be directed by traffic signs. Access will be maintained where possible. ### THE HARINGEY (PARK LANE N17) (TEMPORARY RESTRICTION OF TRAFFIC) ORDER 2024

Made: 23rd October 2024

Coming into force: 23rd October 2024

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited to ensure safety of the public and in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

- **1.** This Order shall come into force on 23<sup>rd</sup> October 2024 and may be cited as the Haringey (Park Lane N17) (Temporary Restriction of Traffic) Order 2024.
- 2. In this Order:-
  - "event day" means a day on which an event is taking place or which is planned to take place at the Tottenham Hotspur FC Stadium, High Rd, Tottenham, London N17; and which is to have an expected attendance of 10,000 persons or more, not including any staff or contractors engaged in either the operation or management of the aforementioned stadia, park, or event.
- **3.** During the period beginning 23<sup>rd</sup> October 2024 for a period of up to 12 months, no person shall cause or permit any vehicle to: -
  - (a) Wait, load or unload in the lengths of roads specified in Schedule 1 to this Order
  - (b) wait, load or unload in the lengths of roads specified in column 2 of Schedule 2 to this Order during days/times specified in column 1 to that schedule
- **4.** 'The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021' and 'The Haringey (Charged-For Parking Places) Order 2021' are hereby temporarily amended as detailed in Article 2(b) and 3 to this Order.
- **5.** The prohibitions and restrictions specified in articles 2 and 3 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
- 6. Nothing in Article 3 (a) & (b) to this Order shall apply to: -
  - (a) any vehicle being used for fire brigade, police or ambulance purposes;
  - (b) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer:
  - (c) to any Council refuse and cleansing motor vehicle;
  - (d) to any contractor working on behalf of Haringey Council
- 7. The Order may continue in force for up to 18 months unless extended by the Secretary of State.


#### a. North side:


- between High Road and the shared use bay opposite No.4/Concord House (across stadium access).
- between the shared use bay opposite No.4/Concord and the permit holders only bay opposite Lancaster Close (across stadium access).
- between the permit holders only bays opposite No.28-32. iii.
- between the permit holders only bays opposite Bromley Road/No.38. ίV.
- between the permit holders only bay opposite No.42 to Worcester Avenue.
- between Worcester Avenue/opposite No.56 to the west end of the school keep clear vi. markings opposite St Pauls Church.
- vii. between the east end of the school keep clear markings opposite No.68 and the west side of the junction with Park Lane Close.
- viii. between the east side of the junction with Park Lane Close to the end of the bollards opposite No.86 (including across the buildout).



- between High Road and the shared use bay outside No.2.
- across the Lancaster Close access.
- between the permit holders only bays outside No.36 & No.38.
- between the permit holders only bays outside No.46. ίV.
- between the permit holders only bay outside No.46/48 to the west side of the junction with Vicarage Road.
- Between the east side of the junction with Vicarage Road to the permit holders only bay outside St Pauls Church.
- Between the permit holders only bays outside St Pauls Church/No.62. vii.
- viii. Between the permit holders only bays outside No.70 & No.72.
- Outside No.84. ix.
- c. On **Bromley Road N17** (both sides): From its junction with Park Lane south for approximately 5
- d. On Worcester Avenue N17 (east side): From its junction with Park Lane, north for approximately 56 metres.
- e. On Vicarage Road N17 (both sides): From its junction with Park Lane south for approximately 19
- f. On Sutherland Road N17 (both sides): From its junction with Park Lane south for approximately 11 metres.
- g. On Park Lane Close N17 (both sides): From its junction with Park Lane, north for approximately 7 metres.


