THE HARINGEY (TOWN HALL APPROACH ROAD N15) (TOTTENHAM WINTER FESTIVAL) TEMPORARY PROHIBITION OF TRAFFIC ORDER 2024

Made: 3rd December 2024

Coming into operation: 7th December 2024

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that traffic should be prohibited by reason of a special event and in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

- 1. This Order shall come into operation on 7th December 2024 and may be cited as the Haringey (Town Hall Approach Road N15) (Tottenham Winter Festival) Temporary Prohibition of Traffic Order 2024.
- 2. Whilst the Order is in force, no person shall cause or permit any vehicle to enter or proceed in the lengths of roads specified in column 2 of the Schedule to this Order during the dates and times specified in column 1 of that Schedule;
- **3.** The prohibitions and restrictions specified in article 2 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
- 4. Nothing in this Order shall apply to: -
 - (a) any vehicle being used in connection with the event;
 - (b) any vehicle being used for fire brigade, police or ambulance purposes;
 - (c) anything done with the permission or at the direction of a police constable in uniform or a traffic warden;
 - (d) any vehicle necessitating access to a property in a prohibited length of road, if the event allows.
