Outcome of Statutory Consultation and Works Notice

Installation of Electric Vehicle Charging Points (EVCP's) - 2024/25 Batch 1

Dear Resident or Business,

You may recall that we consulted you in July-September2024 regarding the possible introduction of 32 Electric Vehicles Charging Points (EVCP's)/bays at 14 locations in the borough. As part of this we also consulted on revised proposals for two locations in Broadland Road N6 and Linley Road N17. We received a good response to the consultation and on behalf of the Council, we would like to thank all those who took the time to have their say and make their views known.

As part of the decision-making process, the council have given careful consideration to all comments and objections received, with the proposed introduction of 28 EVCPs having now been approved. The council will now proceed with the introduction of EVCPs at the locations provided with this letter. These EVCP's will be part of the Source London network and accessible to Source London members and all other users on 'pay as you go' bases.
