Application to the high court: Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it does not comply with the relevant powers of the Road Traffic Regulation Act 1984, as amended or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

The Haringey (Off Street Parking Places) (Amendment No.1) Order 2025

Made: 4th April 2025

Coming into force: 10th April 2025

The Council of the London Borough of Haringey, after consulting the Commissioner of Police of the Metropolis, in exercise of powers conferred by section 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹, as amended and of all other powers thereunto enabling, hereby make the following Order: -

- 1. This Order shall come into force on 10th April 2025 and may be cited as the Haringey (Off Street Parking Places) (Amendment No.1) Order 2025.
- In this Order the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Haringey (Off-Street Parking Places) Order 2017² shall have effect as though the item named "Tottenham Green, N15" in Schedule 1 to that order there were substituted with the item similarly named and set out in columns 1 to 7 of the Schedule to this order.
