Statutory Consultation

Proposed Hornsey North East (HNE) Controlled Parking Zone Extension

Dear Resident or Business,

You may recall that in May of this year we wrote to you asking if you were experiencing parking pressures in your area and whether you supported being included in the Hornsey North East controlled parking zone (CPZ). I am pleased to say over 54% of you responded to provide us with your view. This exceeds the Council's minimum response rate of 10% set out in our Parking Schemes - Resident Engagement Policy to inform a decision. I want to take this opportunity to thank everyone who participated in this process; your views are very important as they help us decide how to move forward.

What you told us

668 properties were sent the information. We received 366 responses. 227 (62%) support the introduction of parking controls, 134 (37%) do not support the introduction of a parking zone, with 1% neither supporting nor objecting.

Street-by-street analysis showed that both South View Road and Hawthorn Road have 117 (78%) and 43 (80%) residents in favour, but North View Road has 80 (55%) residents opposed and 64 (44%) supporting the proposed CPZ extension.

When asked about which day and times the controlled parking zone should operate, 227 respondents (62%) indicated support for the existing Hornsey North East (HNE) CPZ operating days and times, these being Mondays to Fridays, 10 am – 2 pm.

We require at least 51% support to meet the threshold of our Resident Engagement policy for Parking Schemes. With 62% in favour, we can now proceed to the next stage: the statutory consultation process.

What we are going to do

We have decided to approve progressing the extension of the existing Hornsey North East CPZ to North View Road, South View Road and Hawthorn Road. This means we can now move to the formal stage, which is statutory consultation.

Although a small majority of the respondents from North View Road expressed opposition to the extension, excluding North View Road would create significant additional parking pressure for the residents of the road, who would also not be able to park in the surrounding streets during the CPZ operational hours. North View Road would be the only non-controlled parking available in this area and would attract visitors or those who wish to avoid paying for parking. We have therefore made the decision to include North View Road in the statutory consultation for the CPZ extension.

Next Steps

To introduce the proposals and legally enforce their use, we are required to enter into a period of consultation known as 'statutory consultation'. This provides a minimum 21-day period for anyone wishing to object to the proposals.


