

## THE HARINGEY (VARIOUS ROADS - DOCKLESS E-SCOOTER/BICYCLE PARKING PLACES BATCH 2 – TTMO216) (TEMPORARY RESTRICTION OF PARKING) ORDER 2026

The Council of the London Borough of Haringey has made the above Temporary Traffic Order under S14(1) Road Traffic Regulation Act 1984 for public safety and to facilitate dockless e-scooter and bicycle parking.

### THE GENERAL EFFECT OF THE ORDER:

1. To suspend parking in the following lengths of carriageway specified in column 2 to facilitate the introduction of dockless e-scooter and bicycle parking bays during the dates and times specified in column 1, as detailed below:



Coming into force: 9<sup>th</sup> February 2026

The 'Council' of the London Borough of Haringey being the traffic authority for certain roads in that London borough is satisfied that parking should be restricted for public safety and to facilitate dockless e-scooter and bicycle parking and in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, as amended and of all other enabling powers the Council hereby makes the following Order.

1. This Order shall come into force on 9<sup>th</sup> February 2026 and may be cited as the Haringey (Various Roads – Dockless E-scooter and Bicycle Parking Places Batch 2 - TTMO216) (Temporary Restriction of Parking) Order 2026.
2. In this Order:  
“pedal cycle” has the same meaning as in schedule 1 of the Traffic Signs Regulations and General Directions 2016.
3. Whilst this Order is in force, any parking place or loading bay, located in a length of road specified in column 2 of the Schedule to this Order shall be suspended during the dates and times specified in column 1 of that Schedule.
4. Whilst the Order is in force, no person shall cause or permit any vehicle to wait, load or unload in the lengths of roads specified in column 2 of the Schedule to this Order during the dates and times specified in column 1 of that Schedule other than those vehicles exempted from such restrictions specified in column 3 to that Schedule.
5. ‘The Haringey (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) Order 2021’ and ‘The Haringey (Charged-For Parking Places) Order 2021’ are hereby temporarily amended as detailed in Articles 3 and 4 to this Order.
6. The prohibitions and restrictions specified in articles 3 and 4 above shall apply only during such times and to such extent as shall be indicated by traffic signs as prescribed by The Traffic Signs Regulations and General Directions 2016.
7. Nothing in Article 4 to this Order shall apply to: -
  - (a) any vehicle being used for fire brigade, police or ambulance purposes;
  - (b) any vehicle exempted from the restrictions as defined in column 3 of Schedule 1 to this Order;
  - (c) anything done with the permission or at the direction of a police constable in uniform, a traffic warden or a civil enforcement officer;
8. The Order may continue in force for up to 18 months unless extended by the Secretary of State.
